Note

CD71 (also known as TFRC: transferrin receptor) is a widely expressed 180 kDa type II membrane glycoprotein involved in the cellular uptake of iron and in the regulation of cell growth. Iron uptake occurs via the internalization of iron-loaded transferrin mediated by the interaction with the CD71. CD71 expression is increased on rapidly proliferating cells, while expression is decreased or absent on non-dividing cells. Some studies have suggested that biologically aggressive tumors require large amounts of iron for active metabolism and rapid cell growth, and overexpression of CD71 has reported in different types of cancers such as glioma, pancreatic, and colon cancers.

In addition, CD71 is required for adult erythropoiesis and involved in T- and B- cell development. CD71 seems to play an important role in T cell activation, and T cells lacking CD71 are completely arrested at a very early stage of maturation.

This antibody is specific to human CD71 and will be useful for FCM, immunoprecipitation.

CD71 (TFRC: transferrin receptor) は、生体内で幅広く発現している180 kDa の II 型膜糖タンパク質で、鉄イオンの細胞内への取り込みや細胞の成長に役割を果たしています。CD71 は、赤血球形成や T 細胞、B 細胞の発達に関与し、特に T 細胞の活性化に重要な役割を果たしており、CD71 欠損 T 細胞は初期で成熟が停止することが明らかとなっています。

増殖能が高い細胞では CD71 は発現が増加し、非分裂細胞では減少もしくは見られません。また、活性化された代謝や急速な成長に伴い多くの鉄イオンを必要としているため、グリオーマ、膵臓癌、大腸癌などで CD71 が過剰発現していることが示されています。

本抗体はヒトCD71 に特異的な抗体であり、FCM、免疫沈降に使用できます。
