## Anti PACAP 27 (Human) Serum

**Description:** This antiserum was raised in a rabbit by immunization with a carrier free synthetic PACAP 27 (human) peptide. The product vial contains 50  $\mu$ L of the titled antiserum obtained by lyophilizing its 0.001 M phosphate buffer (pH 7.0, 0.5mL) solution. It can be used for immunoassay, immunohistochemistry or any other immunoreaction with PACAP27 (human).

Immunogen: Synthetic PACAP 27 (human) peptide, carrier free Host: Rabbit

Amino Acid Sequence of PACAP27 (human)1):

HSDGIFTDSY SRYRKQMAVK KYLAAVL-NH2

**Product Form:** Lyophilized unpurified serum Size: 50  $\mu$ L

**Reconstitution:** Reconstitute the product with 0.5mL of 0.01M PBS (pH 7.0) to make a 10 fold diluted stock solution. If it is stored in a refrigerator, add moderate antiseptic to the solution (e.g. NaN3 0.1%).

**Storage:** The product will be stable for over one year if it be stored at -20°C to -80°C until opened. Upon reconstitution, the antiserum solution must be stored at 2°C to 8°C and used within one month. Repeated freezing-thawing should be avoided.

**Suggested Working Dilution Range:** 1:5,000-40,000 (final dilution ~1:280,000) for radioimmunoassay; 1: 1,000-4,000 for immunohistochemistry (frozen or paraffin sections). Optimal dilution should be determined by each laboratory for each application.

**Specificity** (based on radioimmunoassay): PACAP27 (human) 100%, PACAP38 (human) 0%, VIP (porcine) 0%, PHI (rat) 0%, PHI (human) 0%, secretin (human) 0%, helodermin 0%

Positive Control (immunohistochemistry): Rat colon

Species Tested: Rat
